3	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
4	SECTION 1. Subtitle D, Title 4, Government Code, is amended
5	by adding Chapter 451 to read as follows:
6	CHAPTER 451. TEXAS 1836 PROJECT
7	Sec. 451.001. DEFINITIONS. In this chapter:
8	(1) "1836 Project" means the advisory committee
9	established under this chapter.
10	(2) "Patriotic education" includes the:
11	(A) presentation of the history of this state's
12	founding and foundational principles;
13	(B) examination of how this state has grown
14	closer to those principles throughout its history; and
15	(C) explanation of why commitment to those
16	principles is beneficial and justified.
17	(3) "State agency" means a department, commission,
18	board, office, or other agency in the executive branch of state
19	government that is created by the constitution or a statute of this
20	state.
21	Sec. 451.002. ESTABLISHMENT. (a) The 1836 Project is
22	established as an advisory committee to promote patriotic education
23	and increase awareness of the Texas values that continue to
24	stimulate boundless prosperity across this state.

The appointees may include persons in the private 4 5 sector with relevant experience or subject matter expertise. (a) The 1836 Project shall: 14 15 (1) promote awareness among residents of this state of 16 the following as they relate to the history of prosperity and 17 democratic freedom in this state: 18 (A) Texas history, including the indigenous peoples of this state, the Spanish and Mexican heritage of this 19 state, Tejanos, the African-American heritage of this state, the 20 21 Texas War for Independence, Juneteenth, annexation of Texas by the 22 United States, the Christian heritage of this state, and this 23 state's heritage of keeping and bearing firearms in defense of life 24 and liberty and for use in hunting; 25 (B) the founding documents of this state; 26 (C) the founders of this state; 27 (D) state civics; and

(b) The 1836 Project is composed of nine members reflective

- 4 (i) President Lyndon B. Johnson's signing

- 14 (3) facilitate the development and implementation of

- 17 (1)(A)-(D);
- 18 <u>(4) advise state agencies with regard to their efforts</u>
- 19 to ensure patriotic education is provided to the public at state
- 20 parks, battlefields, monuments, museums, installations, landmarks,
- 21 cemeteries, and other places important to the Texas War for
- 22 Independence and founding of this state, as appropriate and
- 23 consistent with applicable law; and
- 24 (5) facilitate, advise on, and promote other
- 25 activities to support public knowledge of and patriotic education
- 26 on the Texas War for Independence and founding of this state, as
- 27 appropriate and consistent with applicable law.

- 1 (b) In carrying out its duties under Subsection (a)(2), the
- 2 project may solicit statements and contributions from intellectual
- 3 and cultural figures.
- 4 Sec. 451.004. FUNDING; COMPENSATION. (a) The Texas
- 5 Education Agency shall provide funding and administrative support
- 6 for the 1836 Project, including for the pamphlets described by
- 7 Section 451.005, to the extent funds are available for those
- 8 purposes.
- 9 (b) A member of the 1836 Project is not entitled to
- 10 compensation but is entitled to reimbursement for the travel
- 11 expenses incurred by the member while transacting project business,
- 12 as provided by the General Appropriations Act.
- Sec. 451.005. PAMPHLET. Not later than September 1, 2022,
- 14 the 1836 Project shall provide a pamphlet to the Texas Department of
- 15 Public Safety that explains the significance of policy decisions
- 16 made by this state that promote liberty and freedom for businesses
- 17 and families. The contents must include:
- 18 (1) an overview of Texas history and civics;
- 19 (2) the legacy of economic prosperity in this state;
- 20 and
- 21 (3) the abundant opportunities for businesses and
- 22 families in this state.
- Sec. 451.006. REPORT. (a) Not later than September 1,
- 24 2022, the 1836 Project shall prepare and produce a written report
- 25 that includes:
- 26 (1) a description of the activities of the project;
- 27 (2) the findings and recommendations of the project;

- 1 (3) a plan that identifies the best method of carrying 2 out the duties under Sections 451.003(a)(1), (4), and (5);
- 3 (4) any proposals for legislation; and
- 4 (5) any other matter the project considers
- 5 appropriate.
- 6 (b) Subsequent to the report required under Subsection (a),
- 7 the 1836 Project may prepare and produce additional reports the
- 8 project considers appropriate.
- 9 (c) The Texas Education Agency shall make a report described
- 10 by this section available to the public on the agency's Internet
- 11 website.
- 12 (d) To the extent existing agency resources are available
- 13 for this purpose, the Texas Education Agency may provide to the 1836
- 14 Project any agency resources necessary to prepare or produce a
- 15 report described by this section.
- Sec. 451.007. ABOLITION; EXPIRATION. The 1836 Project is
- 17 abolished and this chapter expires September 1, 2036.
- 18 SECTION 2. Subchapter A, Chapter 521, Transportation Code,
- 19 is amended by adding Section 521.013 to read as follows:
- Sec. 521.013. TEXAS 1836 PROJECT PAMPHLET. (a) The
- 21 department shall provide the pamphlet described by Section 451.005,
- 22 Government Code, to persons who receive a driver's license:
- 23 (1) after applying under Section 521.144; or
- (2) with an expiration provided by Section
- 25 521.271(a-2) or (a-3).
- (b) The department shall make the pamphlet described by
- 27 Section 451.005, Government Code, available to the public on the

1 <u>department's Internet website.</u>

- 2 SECTION 3. As soon as possible after the effective date of
- 3 this Act, the governor, the lieutenant governor, and the speaker of
- 4 the house of representatives shall make the appointments to the
- 5 1836 Project under Section 451.002, Government Code, as added by
- 6 this Act.
- 7 SECTION 4. The Texas Education Agency and the Department of
- 8 Public Safety of the State of Texas are required to implement a
- 9 provision of this Act only if the legislature appropriates money
- 10 specifically for that purpose. If the legislature does not
- 11 appropriate money specifically for that purpose, those agencies
- 12 may, but are not required to, implement a provision of this Act
- 13 using other appropriations available for that purpose.
- SECTION 5. This Act takes effect September 1, 2021.
